## **Trip Notes**

The travel for this adventure will be operated by Flight Centre.

#### B=Breakfast L=Lunch D=Dinner

### Day 1, Saturday 20 October 2012 Australia – Peru

The adventure has begun! Due to crossing the International Date Line, you depart and arrive on the same day. On arrival at Lima Airport you take an early morning flight over the Andes that brings you to Cusco, where you are met by your guide and transferred to your hotel in central Cusco. Today is for acclimatisation to the altitude of the Andes (3,240m). Ensure you drink plenty of liquids and take it easy. After lunch in a typical local restaurant, we take a short walk through central Cusco in the afternoon.

# Day 2, Sunday 21 October 2012 Peru's Challenge School

Today we visit the Peru's Challenge site just outside Cusco and have a first-hand experience of project work in Peru. We enjoy lunch with the project workers and some of their beneficiaries before returning to Cusco in the late afternoon.

## Day 3, Monday 22 October 2012 Cusco and Pisac

Spend another day exploring Cusco and the Sacred Valley, learning about the Inca heritage of Peru. As today's touring takes you to 3,650m, it's also the perfect way to continue to acclimatise to the altitude and prepare yourself for the trek ahead. Leave Cusco early in the morning for the picturesque village of Pisac, famous for its markets and artisan stalls. Shop or visit the extensive Inca ruins at the top of the hill, taking a hike along a well-defined route through royal buildings, look-outs, terraces, tunnels and irrigation channels. After a picnic lunch we head back to Cusco, exploring some of Cusco's outlying Inca sites en route including Tambo Machay, Qenqo and the ruins of Sacsayhuaman.

## Day 4, Tuesday 23 October 2012 Cusco – Quishuarani

Today we commence our 4-day trek through the beautiful Lares Valley, an alternative to the Inca Trail with fewer crowds and some dramatic scenery. Departing Cusco early we descend into the Sacred Valley before heading high into the Andes. We begin our hike up an ancient Inca trail, through a narrow canyon where Inca burial tombs can still be seen. From here there is the option to continue walking or meet our bus further up the valley and transfer over a 4,200m pass to the small community of Quishuarani to set up camp for the night.

Trek distance: 8km Meals: B, L, D

## Day 5, Wednesday 24 October 2012 Quishuarani – Cuncani – Huacahuasi

We begin the day's hike with a climb out of the Quishuarani valley. We are likely to meet some local people in their brightly coloured garb and throughout the day will have the chance to barter for beautiful handmade textiles. Our trekking path today also traverses the native tree reforestation project of ECOAN. This restored ecosystem is home to several bird species common in the area. We descend past some spectacular waterfalls and crystal clear lakes to the small village of Cuncani, where we meet our support vehicle for lunch. The afternoon has many options: either a short walk over the ridge to the village of Huacahuasi or a scenic hike to the Lares hot springs, before transferring by support vehicle to our camp on the Huacahuasi football pitch.

Trek distance: 18 km

## Day 6, Thursday 25 October Huacahuasi – Patacancha

Today we set off for our final challenge – to climb over a 4,100m pass and descend towards the Sacred Valley of the Incas. We take it slow and steady, stopping to admire the beautiful lakes, arriving at the pass just before lunch. Admire the spectacular views of the snowy Mount Veronica and perhaps get a glimpse of a soaring condor, before descending along an old mule trail to the village of Patacancha. Our support vehicle will meet us here and take us to Huilloc where we set up camp on a field just outside the village. Huilloc is famous as the breeding ground for Inca Trail porters and the traditional Andean way of life is still evident here. Quechua is the dominant language and many of the local people still wear traditional dress. This is our last chance to barter for more fine weavings before finishing our trek.

Trek distance: 15 km Meals: B, L, D

## Day 7, Friday 26 October 2012 Huilloc – Pumamarca – Aguas Calientes

Today begins with a short sharp climb to the impressive and rarely visited ruins of Pumamarca. After exploring this extensive site, we follow an ancient Inca trail along the many terraces of the Huilloc valley as we wind our way through eucalyptus forests to end our trail nearby the impressive ruins of Ollantaytambo. After lunch, we catch the late afternoon train to Aguas Calientes, our base for exploring Machu Picchu, and check into our hotel. The evening is free to explore the colourful artisan market and the many lively bars and restaurants.

Trek distance: 7km Meals: B, L

## Day 8, Saturday 27 October 2012 Machu Picchu – Cusco

A short bus ride brings you to Machu Picchu, 'the lost city of the Incas'. Your guide leads you on an extensive walking tour, explaining the fascinating history of the Incas. If time permits you may wish to explore further. There are a number of options – you could walk back up the Inca Trail to the sun gate or try the strenuous climb of Huayna Picchu for an awe-inspiring condor's eye view of Machu Picchu. We catch an afternoon bus back to Aguas Calientes for a late lunch and transfer to the train



station for the afternoon train back to Ollantaytambo. From here we take a bus on to Cusco where we drop you off at the hotel.

Meals: B, L

### Day 9, Sunday 28 October 2012 Cusco

Enjoy a free day in Cusco for some rest and recuperation. If you're feeling more active, there is no shortage of things to do in Cusco – from exploring Inca ruins to visiting colonial churches, bargain hunting in the local markets or whiling away the hours in a cafe. In the evening we meet up for celebratory dinner and those with the energy can go on to discover Cusco's excellent nightlife.

## Day 10, Monday 29 October 2012 Depart

Say farewell to the Andes and Peru as you transfer to Cusco Airport for your return flight to Lima to connect with your international flight home.

# **Frequently Asked Questions**

#### How do I fundraise?

Past participants have successfully fundraised in many creative and fun ways. We will send you a comprehensive Fundraising Toolkit upon registration to help you reach your target. You will also have regular support from our Inspired Team, who will help you develop and manage your fundraising plan, as well as support from the charity for which you are fundraising.

#### What does it cost?

Upon registration, you pay a registration fee of \$700. The travel cost and donation to the Black Dog Institute can be fundraised with the support of Inspired Adventures.

#### Is my donation tax deductible?

The funds raised for the charity are tax deductible (conditions apply). Funds raised to cover travel costs are not tax deductible.

#### What's included?

- Return international flights with LAN Airlines departing from Sydney and Melbourne.
- All transfers
- Accommodation on twin share basis in 3 star hotel and comfortable camping.
- Meals as indicated in itinerary
- All guides, crew, cooks and porters
- All camping gear, including mess tents, tents (twin share)
- · First Aid medical kit
- All park and camping fees
- Inspired Adventures Social Leader when group size over 10

#### What's not included?

- Airline taxes (approx. \$510 ex sydney, subject to change until ticketed)
- Tips
- Visas
- · Purchases of a personal nature
- Personal equipment including backpacks, therm-arest and sleeping bag.

#### How fit do I need to be?

This trek is ranked 4/5.

It involves trekking or climbing for up to 7 hours a day for 5 or more days at a steady pace with difficult stages lasting either a few hours each day or a few days of the

entire trip. You will be expected to carry a daypack containing basic items needed on the day that should weight 5–7 kilograms. You will need a good level of fitness and be in good health.

Our adventures are specifically designed for people who are relatively fit and willing to train. We recommend that in the months leading up to your trip, you increase your physical fitness with aerobic exercise. Walking, running and stair-climbing will all strengthen your legs and improve your stamina.

### Can I extend my stay?

Of course, many of our participants decide to extend their stay to get the most from their overseas adventure! (Additional travel arrangements are at your own cost).

# What is the minimum age and general age range of participants?

The minimum age is 16 years old with accompaniment by an adult. We have had participants of all ages from 16–70 years, all united by their sense of adventure.

# Will I get a chance to meet other people before we go?

Yes, we will organise a get-together evening for everyone (geography permitting). There will be regular email and phone communications leading up to the trip. We will also set up an online community on Facebook for this adventure so you can meet other participants.

#### How do I register?

This Inspired Adventure is operated by Flight Centre Ltd.

Please read carefully the terms in the conditions of contract in completing and submitting the Booking Form. you agree to be bound by these conditions which constitute the agreement between Inspired Adventures, Flight Centre Ltd (Flight Centre) and you. The conditions apply to the exclusion of any other terms or conditions unless they are set out in the Booking Form, or are otherwise agreed to in writing by the parties. Previous dealing with the parties will not vary these conditions. No purported variation of these conditions will be effective unless in writing and signed by a person so authorised by Inspired Adventures and Flight Centre.

- 1. How to Book: To participate in this Inspired Adventure, you must pay a non-refundable registration fee of AUD\$700 including GST payable to Inspired Adventures. Six weeks later you must pay a non-refundable travel deposit of AUD\$400 including GST which must be made payable to Flight Centre. If you register within 4 months of the departure date you must pay the travel deposit of AUD\$400 immediately upon registration.
- 2. Payments and Fundraising: Eligibility to take part in this Challenge is contingent upon you raising the minimum Fundraising Target. Flight Centre will not accept receipt of your balance payment until there is evidence that your Fundraising Deposit of AUD\$1,000 has been met 20 weeks prior to your departure. The balance of your Fundraising Payments must be made no later than 4 weeks prior to your departure. Travel costs are based on arrangements departing from the published departure city/cities in Australia and exclude travel insurance & visa fees. Flight Centre may be able to arrange travel from other cities in Australia, a surcharge will apply. Registered participants will be required to cover additional travel or accommodation costs required as a result of departing from an alternative destination. Failure to lodge the fundraising target on or before the required date will render you ineligible to depart on the Challenge and you will forfeit in full the AUD\$700 registration fee paid to Inspired Adventures, the AUD\$400 travel cost deposit paid to Flight Centre, and your place on the adventure. All monies raised in the name of the **charity** must be forwarded immediately to the **charity** along with supporting documents as outlined in the 'Conditions of Fundraising'. #### Prices:

All prices are subject to availability and can be withdrawn or varied without notice. The price is only guaranteed when paid in full. Please note that prices quoted here are subject to change and will be re quoted at the time of full payment. Price changes may occur by reason of matters outside our control which increase the cost of the product or service. Such factors include adverse currency fluctuations, fuel surcharges, taxes and airfare increases. Please contact your Consultant

#### Refunds, Changes and Cancellation Fees:

We are unable to provide a refund to you until we receive the funds from the relevant supplier. Cancelled bookings will incur charges. These charges can be up to 100% of the cost of the booking, regardless of whether travel has commenced. Fees and extra charges will apply where a booking is changed. Fees and extra charges will also apply when tickets or documents are re-issued. Where we incur any liability for a cancellation fee or charge for any booking which you cancel, you agree to indemnify us for the amount of that fee or charge.
