Our researchers

Many researchers enter the field because their lives have been personally touched by cancer. One of Cure Cancer Australia Foundation's 2010 grant recipients heard that his father had been diagnosed with lung cancer when he was 2 years into his PhD. Gough Au comments, "It gives you a purpose. It's the sense of contribution. It is who I am as a person – I want to make a difference. I have seen what patients go through, there is a personal element to it."

Dr. Caroline Ford's interest in ovarian cancer was sparked when she realised how little we know about this prevalent disease. "I believe this is a disease in which much basic research can be done, and that there's the opportunity to make significant differences to outcomes," she says.

Receiving the Cure Cancer Australia Foundation grant has allowed researchers like Gough and Caroline to pursue their work as independent researchers. "It's been a fantastic help. It will enable me to determine if our hypothesis is valid and develop the pilot into a significant long-term research project," Caroline hopes.

Inspired Adventures Booking Conditions

Please read carefully the terms in the conditions of contract in completing and submitting the Booking Form, you agree to be bound by these conditions which constitute the agreement between Inspired Adventures and you. The conditions apply to the exclusion of any other terms or conditions unless they are set out in the Booking Form, or are otherwise agreed to in writing by the parties. Previous dealing with the parties will not vary these conditions. No purported variation of these conditions will be effective unless in writing and signed by a person so authorised by Inspired Adventures.

1. How to Book:

To participate in this Inspired Adventure, you must pay a non-refundable registration fee of AUD\$700 including GST payable to Inspired Adventures.

2. Payments and Fundraising:

Eligibility to take part in this Challenge is contingent upon you raising the minimum Fundraising Target. The balance of your Fundraising Payments must be made no later than 4 weeks prior to your departure. Registered participants will be required to cover travel or accommodation costs required. Failure to lodge the fundraising target on or before the required date will render you ineligible to depart on the Challenge and you will forfeit in full the AUD\$700 registration fee paid to Inspired Adventures and your place on the adventure. All monies raised in the name of the **charity** must be forwarded immediately to the **charity** along with supporting documents. Inspired Adventures and the charity reserve the right to refuse your Application to Register. Their decision is final and binding. Should your Application be refused your full registration fee will be refunded to you. Your registration for the Challenge will take effect once your registration funds have cleared. Places are limited on the Challenge and are allocated on a first come first served basis.

3. Cancellations by You:

If you wish to cancel your trip, you must notify Inspired Adventures in writing. All cancellations will forefit the non refundable registration fee.

4. Image and Likeness:

I grant Inspired Advetures the right to take photographs and videos of me and my property in connection to my participation on an inspired adventure. I authorise Inspired Adventures, its assigns and transferees to copyright, use and publish the same in print and/or electronically.

5. Health, Fitness, Trip Grades and Age Limits:

It is your responsibility to advise Inspired Adventures of any pre-existing medical condition and/or disability that might reasonably be expected to increase the risk of you requiring medical attention, or that might affect the normal conduct of a tour and the enjoyment of other trip members. You may be required to provide an assessment of your medical condition from a qualified medical practitioner if requested.

All travellers seventy years and over will be required to complete a special Inspired Adventures health and fitness questionnaire to assess their suitability of the tour in question. At the discretion of Inspired Adventures, travellers may also be required to provide a doctor's letter clearing them for their specific tour.

6. Complaints:

If you have any complaint about your trip, you must make it known at the earliest opportunity to Inspired Adventures, who will normally be able to take appropriate action. If at the end of the trip you feel your complaint has not been properly dealt with you must notify us in writing within 30 days of the end of your trip.

7. Travel Insurance:

It is a prerequisite of participation in an Inspired Adventure that you have adequate travel insurance.

8. Visas and Passports:

You are responsible for obtaining all necessary immunisations and visas and bear the expense for the same. You must have a valid passport, which has at least six months validity beyond your return date.

9. Disclaimer:

You accept that:

 Inspired Adventures and the charity reserve the right to refuse my Application to Register. Their decision is final and binding. Should my Application be refused my full registration fee will be refunded to me. My registration for the Challenge will take effect once my registration funds have cleared. Places are limited on the Challenge and are allocated on a first come first served basis.

10. Release and Waiver of Liability:

In consideration of Inspired Adventures accepting your booking application and in consideration of you being permitted by Inspired Adventures to join the tour:

 you waive any and all claims I may now or in the future have against Inspired Adventures, its officers, employees, agents or representatives ("its staff") and release from all liability and agree not to sue Inspired Adventures or its staff for any personal injury, death, property damage or loss sustained by me as a result of my participation in the Challenge. You acknowledge that the Challenge involves an adventure trip and accept all the inherent risks associated with such a trip and the possibility of personal injury, death or property damage or loss resulting there from.

To the extent permitted by law, section 74 of the Trade Practices Act 1974 does not apply to this contract.

11. Privacy:

In order to be able to supply a service to you Inspired Adventures may need to collect certain information from you, some of which may be of a personal nature. The information may be disclosed to, or collected on our behalf by our service providers to enable the services to be provided, but will not be used by them for any other purpose.

12. Booking made in Victoria:

This condition 12 and the following statutory warning apply if the booking is made in Victoria. Sections 32J and 32JA of the Fair Trading Act 1999 Victoria (as amended) do not apply to this contract, being a contract for the supply of recreational services.

Under section 32N of the Fair Trading Act 1999, the supplier is entitled to ask you to agree that these conditions do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the services were not rendered with due care and skill or they were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this form.

NOTE: The change to your rights, as set out in this form, does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the in the Fair Trading (Recreational Services) Regulations 2004.

13. Jurisdiction:
